Overview and Challenges

NKT consists of two standalone companies: NKT (provider of power cable solutions) and NKT Photonics (supplier of optical lasers, crystal fibers and fiber optic sensing solution).

The company's legacy financial consolidation and reporting solution, Comshare FDC, was going off on support and it was time to convert to a modern solution that could carry them forward. NKT was looking for a flexible and user-friendly solution that Group Finance could own and administer. They also wanted a solution that could support their current as well as future requirements. After evaluating several alternatives, NKT selected OneStream.

The Solution

Lift and Shift

At the onset of the OneStream project implementation, NKT was in the process of acquiring Swedish-Swiss High-Voltage Cable Manufacturer, ABB HV Cables from the ABB Group. The acquisition was completed on March 2017. With limited time and resources available, NKT initially performed a 'lift and shift', implementing OneStream with the exact metadata structure as their old system.

The Rebuild

After the 'Lift and Shift', the NKT team was looking to expand the use of their OneStream platform by adding support for the new IFRS 16 requirements, account reconciliations, and planning & forecasting. AMCO also helped them create a direct integration between OneStream and their SAP ERP system.

Aligning Lease Accounting with Financial Reporting

To support their lease accounting requirements, AMCO worked with NKT to leverage on their existing platform and its relational blending capabilities to capture the details of lease contracts, perform the IFRS 16 calculations, and generate applicable journal adjustments impacting their balance sheet and income statement.

Gaining Control over Account Reconciliations

With a large volume of account reconciliations to manage, AMCO carried out work on their functional requirements to help support the finance team's strategy and enable the shared service center account reconciliations to document their work and findings.

Improving Agility in Planning and Forecasting

Having streamlined financial close and reporting, then adding lease accounting and account reconciliations, the NKT finance team was ready to revamp their planning and forecasting. AMCO assisted NKT in extending their OneStream implementation to planning and forecasting by replacing multiple Excel spreadsheets with OneStream data entry forms.
